ESSENTIAL FUNCTIONS:

- Provides outpatient psychotherapy and follow-up services to the adult client population.
- Develops and implements individualized treatment/service plans for ACT consumers using various therapeutic methodologies, maintaining a direct service level of 75% minimum time.
- Participates in Case Conferences with all levels of psychiatric and clinical staff, individually and in group supervision staffings.
- Serves as a member of Assertive Community Treatment Team as well as the after hours on call rotation.
- Initiates appropriate Intra & Interagency contact to facilitate consumer care.
- Prepares, maintains and submits all assigned case records, charts, reports, forms and other required documentation in a professional and timely manner.
- Adheres to all policies, laws, regulations and codes of ethics and confidentiality as outlined by federal and state laws, and agency policies and procedures.

REQUIRED QUALIFICATIONS:

- Master's Degree in Social Work, Psychology or related social services field with progressive experience in human services, is desirable.
- Minimum 2 years of mental health experience.
- Ability to carry out rehabilitation and support functions.
- Experience working with adults with serious mental illness.
- Demonstrated ability to obtain vital information during a personal interview to make proper recommendations.
- Demonstrated ability to establish and maintain effective working relationships with internal staff, providers, and other social service agencies.
- Must successfully obtain Criminal History Clearance from the PA State Police, Child Abuse Clearance from the PA Department of Human Services and FBI Fingerprint Clearance.

- Ability to inspect and identify violations pertaining to program regulations.
